Students wear dance attire/sweats & appropriate footwear for the clinic. Each School will wear their school uniform/costume for the halftime performance.

Please Note! NBA/STAPLES CENTER policy requires all guests to pass through security, including a search of all carry-in items.

All participants entering and exiting STAPLES CENTER are to use the 11th Street Entrance, located on the Main Level at Section Loge 113. Everyone entering the building must present a game ticket. NO EXCEPTIONS!

The game will be sold out! Tickets may not be available for walk-up sales. If you need additional tickets, contact MDDTUSA (562-628-9181) regarding availability.

Miss Dance Drill Team USA will NOT provide lunches. Advisors & Students MUST bring their own lunches, snacks and refreshments. .
